## Rules & Standards

**Eligibility:** The show is limited to those that serve the outdoor community with products and services. Whatcom Outdoor Expo reserves the right to determine eligibility for any person, company, or organization.

**Sublets:** Exhibitors shall not assign, sublet or apportion the whole or any part of their space without written permission from Whatcom Outdoor Expo.

**Sales:** Non-Exhibiting manufacturers or companies are not permitted to solicit business at the show exhibit halls or nearby city properties. Exhibitors may sell from their booth only and are responsible for all applicable taxes.

**Cancellation:** If any exhibitor cancels or reduces space prior to March 1st, Whatcom Outdoor Expo shall retain 25% of the booth fee. All cancellations shall be in writing. If any exhibitor cancels after March 1st, no refund will be made. Whatcom Outdoor Expo reserves the right to assign any space not claimed and occupied by 15 minutes prior to show opening.

**Installation and Dismantling of Exhibits:** Each exhibitor agrees to abide by the schedule for set-up and dismantling. No exhibitors shall be allowed to remove any part of their display until the show officially closes. Each exhibit must be self standing (don't borrow a neighbor's booth to hold up yours).

**For the Good of the Show:** Exhibitors will keep their exhibits open and staffed during show hours. All exhibitors and all staff will conduct themselves in a professional manner. Exhibitor agrees that the management may substitute the actual space assigned for the mutual benefit of all exhibitors.

**Liability:** To the fullest extent permitted by law, you agree to defend, indemnify, and hold harmless Whatcom Outdoor Expo from and against any and all claims, damages, losses and expenses, including but not limited to attorney's fees, arising from out of or resulting from the negligent acts or omissions of Whatcom Outdoor Expo or its subcontractors, agents or employees in the performance of the work under this contract. In addition, you acknowledge that the owners of our exhibit space and its related facilities do not maintain insurance covering exhibitor's property or liability for personal or property damage carried by exhibitor and that it is the sole responsibility of the exhibitor to obtain insurance covering any such loss.

**Literature, Fliers & Handouts:** Brochures, fliers and handouts may only be distributed from your booth.

**Music, Video & Live Performance:** No live or recorded music or videos may be used/played or performed without prior approval. Whatcom Outdoor Expo retains the right to, at any time during the show, turn down the volume if we determine the sound interferes with the show.

**Inability to Perform:** If Whatcom Outdoor Expo is prevented from holding the show for any reason, or if it cannot permit the exhibitor to occupy their space for any reason including, but not limited to, strikes, civil disobedience, or acts of God, Whatcom Outdoor Expo's only obligation will be to refund the registration fee paid by the exhibitor. Whatcom Outdoor Expo shall have no further obligation to the exhibitor.
